CONTACTS AND COMMUNICATION

1. How will I receive updates about programs?

The Programs Abroad Office will contact students that that are pending, accepted, or committed to programs directly via email with updates as soon as they become available. The FAQs document will be updated frequently throughout each semester as more information becomes available.

2. Who can I contact at the University of Tennessee about the Coronavirus, or Covid-19, as it relates to my education abroad program?

DECISION-MAKING

- 3. How is the University of Tennessee, Knoxville monitoring the Covid-19 situation worldwide?

 UT is monitoring Covid-19 in close cooperation with the Overseas Security Advisory Council (an office of the US Department of State), the Centers for Disease Control and Prevention (CDC), and our private health, safety and security partners. - **4.** How does UT make decisions about its education abroad program statuses?

 UT consults the Centers for Disease Control and Prevention, the US Department of State, and our private health, safety, and security partners. When making decisions about specific programs, UT also considers local conditions, important dates and deadlines, and input from peer institutions and overseas partners.
- 5. When will I know if my education abroad program is running as planned or if it will be canceled? Program plans will move forward unless you receive notification of a suspension or cancelation decision. Students should avoid making financial commitments on items such as flights or housing. The Programs Abroad Office will communicate with applicants regularly and provide program information and status updates directly via email.

We anticipate any necessary cancelation decisions to be made in October for spring programs and in March for May, mini-term and summer programs. Fall and academic year programs will have varying timelines during late spring and summer for possible cancelation.

STATUS OF FUTURE PROGRAMS

7. What is the status of future education abroad programs?

Education Abroad programs for spring, mini-term, and summer 2021 are proceeding as planned, with some exceptions. Spring break 2021 programs have been moved to the beginning of May. Although education abroad programs were canceled for 2020, we are cautiously optimistic that conditions in some or all of our program locations will improve. The pandemic has affected cities, countries, and regions of the world differently. The Programs Abroad Office will continue monitoring situations and communicating status updates and further developments to applicants directly via email.

8. If I applied to a non-UT sponsored program with a UT affiliate (i.e. CEA, CIEE, IES, ISA, etc.,), am I eligible to particiapte in one of their educaton abroad programs?

You may be eligible to study abroad if your program provider has not canceled your program and there is not a CDC Level 3 Health Notice or a Department of State Level 4 Travel Advisory for the host country when the program begins. Depending on your program start date, your program may or may not be affected. Please stay in communication with the Programs Abroad Office about your program status.

PROGRAM CANCELATIONS

9. What's the difference between program cancelations and program suspensions?

If your program is canceled, it is no longer running for the term. It may be offered again in the future. If your program is suspended, it is on hold. The Programs Abroad Office will communicate status updates and offer alternatives to students.

10. What happens if an education abroad program is canceled?

Academic Information

If programs are canceled, UT will work with students to identify alternative academic options. The University is committed to supporting our students' academic success. In all cases, the Programs Abroad Office will work with our partner institutions and organizations, as well as the student's academic department at UT to identify appropriate academic solutions. Online/remote coursework or other opportunities may be available as an alternative for you. The Programs Abroad Office will communicate such possiblities directly to students.

We will also work closely with the Office of Financial Aid and Scholarships to provide support and guidance where appropriate. Moreover, students should always consult with their academic advisors regarding their academic plans.

Financial Information

If you plan to partcipate on a UT Faculty-directed, Academic Internship or Exchange program and it is canceled prior to the start date, you will **not** be charged tuition or any fees associated with the program.

If you are participating in a UT Affiliate or Direct program, you would need to contact those organizations to learn what costs are refundable. In most cases UT partner organizations such as affiliates and direct programs will make every effort to waive or reduce fees associated with study abroad in emergency situations.

WITHDRAWALS

11. What happens if a student withdraws from a future education program out of concern for Covid-19?

UT understands that personal tolerance for risk may vary, and that final decisions will be made between a student and their family/financial supporters. If a student chooses to withdraw from a future education abroad program after committing to participate, the student will be subject to the terms of the applicable withdrawal policy which can be found in the students' Vols Abroad portal and, if applicable, their program provider's documentation. Should the Programs Abroad Office ultimately cancel a UT Faculty-Directed, Academic Internship or Exchange program prior to the start date (even after the student has withdrawn), the student will receive a full refund of the program fee, tuition (if applicable), and study abroad administrative fee.

12. What happens if I want to leave a current program early due to Covid-19?

UT will make every effort to assist any student that wishes to leave their host country/program early. They should understand important policies and procedures prior to their withdrawal or departure. INSURANCE

14. Should I purchase trip cancelation or interruption insurance and/or refundable airfare?

The Programs Abroad Office strongly recommends that students purchase fully refundable airline tickets and trip protection insurance to safeguard against losses or penalties associated with withdrawal or program cancelation. The Programs Abroad Office assumes no responsibility for such losses or penalties.

15. Is medical care for Covid-19 covered by insurance?

Education abroad insurance coverages typically include medical care if you become ill for a wide variety of reasons, including a Covid-19 diagnosis. Students would consult with their program contacts on-site, local medical professionals, and the insurance provider to determine the best course of action, in the event of infection. This could include receiving care locally or a medical evacuation if deemed necessary.

GUIDANCE and COVID-19

16. What is the protocol for Covid-19 in my host country?

The protocol for traveling to and from international destinations, and that country's Covid-19 information and data reporting, is country-specific. The best place to find information on COVID-19 in a specific country is through that country's Ministry of Health and government websites, US Embassies and Consulates overseas, the Center for Disease Control and Prevention (CDC), and the U.S. Department of State.

Students should expect to follow all guidelines for Covid-19 in their host country. These can change prior to or during a program. Your program contacts will maintain regular communication with you and share important information as soon as it becomes available.

17. Will the program I choose be different compared to previous programs because of Covid-19?

Programs are designed to give students great academic experiences and provide opportunites to see their subject area in a new way with local immersion. Although immersion may look different and adjustments may be necessary, programs always strive to include rewarding, hands-on experience with coursework and out-of-class experiences. The Programs Abroad Office is working closely with our program leaders and providers to best understand and implement all the ways this is possible.
